EXPRESSION OF INTEREST FOR THE PROVISION OF ACCOMMODATION

Kamra tal-Periti is issuing an Expression of Interest (EOI) to individuals, businesses, and organizations for the provision of accommodation for 15 Palestinian architecture students and 3 tutors participating in a transformative educational program this summer.

Project Overview

In collaboration with Birzeit University, Kamra tal-Periti is hosting a pop-up studio in Malta. This initiative, supported by the Ministry for Foreign and European Affairs, aims to merge Palestinian and Maltese architectural and cultural perspectives, offering an enriching experience for the students. The program is scheduled for 2 or 3 weeks towards the end of July, with exact dates to be confirmed.

Accommodation Needs

The provision of comfortable, safe, and accessible accommodation is crucial for the success of this educational experience. The students and their tutors need housing that is preferably located within Central Malta or South of Malta which will facilitate easy travel to and from the pop-up studio and other program-related activities.

Specifications

- Number of Beneficiaries: 18 (15 adult students + 3 tutors)
- Duration of Stay: Approximately 2 to 3 weeks
- Period of Accommodation: End of July 2024
- **Type of Accommodation**: Apartments, houses, hostels, or student dormitories that can accommodate the group together or in close proximity.
