Election for two (2) members on the Periti Warranting Board

Member elected from the list of Periti Arkitetti

Since she was the only candidate from the list of Periti Arkitetti, Perit Ann Marie Delicata was declared elected from the list of Periti Arkitetti and therefore shall fill the seat on the Periti Warranting Board in terms of Chapter 622 of the Laws of Malta for a period of eighteen (18) months and on the Periti Warranting Board in terms of Chapter 390 of the Laws of Malta for a period of two (2) years.

In the first count, the candidates obtained the following results:

- Perit Joseph Bugeja 96
- Perit Kenneth Rausi 74
- Perit Josianne Vassallo 87

Since in the first count, Perit Kenneth Rausi obtained the least amount of votes, he was eliminated and his votes were redistributed as follows:

26 votes were transferred to Perit Joseph Bugeja, 18 votes were transferred to Perit Josianne Vassallo whilst 30 votes were non-transferable.



Therefore the total number of votes which the candidates had after the closing of the second count was the following:

Perit Joseph Bugeja 122 Perit Kenneth Rausi eliminated Perit Josianne Vassallo 105

Since after the second count, none of the candidates had a total of votes which exceeds 50% of the total valid votes, Perit Josianne Vassallo who had the least amount of votes, was eliminated and her votes were redistributed as follows:

52 votes were transferred to Perit Joseph Bugeja whilst 53 votes were non-transferable.

Therefore the total number of votes which the candidates had after the closing of the third count was the following:

Perit Joseph Bugeja174Perit Kenneth RausieliminatedPerit Josianne Vassalloeliminated

Since after the closing of the third and final count, the only remaining candidate was Perit Joseph Bugeja he is the winner of this election.

The result report of this election as issued by the electronic system utilised for this election is herewith attached.

ELECTED: Perit Joseph Bugeja

Therefore Perit Joseph Bugeja shall fill the seat on the Periti Warranting Board in terms of Chapter 622 of the Laws of Malta for a period of three (3) years and on the Periti Warranting Board in terms of Chapter 390 of the Laws of Malta for a period of two (2) years.


