In Malta, Premju Emanuele Luigi Galizia was organised by the KTP.

## 4. Ratification of Manifesto on digitalisation

Transformation of the construction industry to include a larger portion of digitalisation i.e. BIM, AI, robots, 3d Printing, pre-fabrication, etc.

Voted in favour of this advancement in our industry; note that ACE is not in favour and it is not clear why not from the documentation so far.

#### 5. Ratification of the Madrid Declaration 2018: Water, the future that we want

Outline of how Goal 6 of UNESCO ('Ensure availability and sustainable managements of water and sanitation for all') may be achieved through engineering, with particular reference to the Iberian peninsula. A set of actions to be taken have been proposed.

This paper will be appearing at the EU and way forward for all nations identified.

7. **Discussion and ratification of ECCE being part of the EEAG** (Engineers Europe Advisory Group) organised by FEANI

ECCE seems to have an issue as to its role – equal role of FEANI and ECCE within this group? ECCE wants to ensure equal partnership and which other organisations will be part of this consortium; original FEANI letter stated that the Advisory Group will be providing advice to the FEANI Executive Board ECCE keen in discussing other issues other than education or mutual professional recognition No decision taken by ExBo regarding this point as yet.

- 8. **Status report**: ECCE book "The history and role of civil engineers through the centuries" *KTP sent contribution to this publication. It was later decided that the publication will not include the individual's countries contributions, but that these will be published as a separate publication later on.*
- 9. **Discussion**: ECCE position paper on "the need for structural/seismic rehabilitation of existing buildings in parallel with energy efficiency improvements"

Paper focuses on the Mediterranean region and other European countries; paper to be presented to other EU member states and Brussels in order to convince them to grant funding for the structural and/or seismic upgrade of buildings before, or at least with, the grants given for the upgrade of the energy performance in buildings. Emphasis is made on the fact that if energy performance upgrades are done on structural/seismically unstable buildings, then the upgrade would have been done unnecessarily. Paper will ultimately seek to change wording on various EU directives to include the structural/seismic upgrade of the buildings in conjunction with an upgrade in energy performance exercise.

#### FEANI'S DECLARATION OF MALTA, 5th October 2018

Whereas FEANI is a federation of professional engineers that unites national engineering associations from 34 European Higher Education Area (EHEA) countries,

Whereas FEANI is striving for a single voice for the engineering profession in Europe and wants to affirm and develop the professional identity of engineers, through its activities and services,

Whereas FEANI is a founding member of the World Federation of Engineering Organisations (WFEO) and collaborates with many other organisations dealing with engineering and technology issues and engineering education,

Whereas FEANI is officially recognised by the European Commission as representing the engineering profession in Europe. The federation also has consultative status with UNESCO, UNIDO and the Council of Europe,

Whereas our planet faces massive economic, social and environmental challenges. To combat these, the United Nations Sustainable Development Goals (SDGs) define global priorities and aspirations for 2030. They represent a necessary pathway and an unprecedented opportunity to eliminate extreme poverty and put the world on a sustainable path,

Whereas Engineers are key actors in the Society providing technical expertise, we have a responsibility to support the SDGs in all the economic, social, and environmental organizations we serve, and that Engineers already incorporate in their everyday activities many elements serving the SDGs,

#### 6. Comments from the Vice-President

Need for a world-café forum where all countries form groups to write best practice guidelines in areas such as; digital transformation, STEM projects, SDG (for each country), how to get more members joining FEANI; and the need to raise awareness with members of the public. This is meant to get more value on the experience from the group.

Ing Zammit commented that although this is a good initiative, there is a divergence of opinion of what makes one an engineering. A similar venture in ECEC where a training schedule had been put in place failed due to the input of many ideas.

There are the academic and vocational routes in becoming an engineer, and so far, there is no convergence. Whether one takes the educational or training routes, this does not matter as long as there is a scheme.

A formal agreement has been reached to set up Engineers Malta. This will consist of members of the Kamra tal-Periti and Chamber of Engineers and will be a new National FEANI committee.
