Avviz lis-Sidien ta' Vetturi li Tnehbew mit-Triq

Skont ir-Regolamenti dwar l-Ikklampjar u t-Tnehhija ta' Vetturi bil-Mutur u Oggetti ta' Ingombro SL.65.13, Transport Malta qiegħda b'dan l-avviz tippubblika lista ta' vetturi li tnehbew mit-toroq għar-raġuni li marru kontra l-Att dwar ir-Registrazzjoni ta' Vetturi bil-Mutur (Kap. 368) u Regolamenti dwar ir-Registrazzjoni u l-Liċenzjar ta' Vetturi bil-Mutur, L.S. 368.02 u li ma ttiħdux lura mis-sidien legali tagħhom.

Il-lista tinkludi deskrizzjoni tal-vettura. Dawn il-vetturi qed jiġu miżmuma fil-compound ta' Transport Malta.

Is-sidien rispettivi huma ġentilment mitluba sabiex jiehdu lura l-vettura tagħhom mingħand Transport Malta billi jissottomettu prova li huma s-sidien tal-vettura inkwistjoni filwaqt li għandu jsir il-hlas tat-taxxa tar-registrazzjoni applikabbli, liċenzji, kontravenzjonijiet u miżati amministrattivi oħra li jkun dovuti.

Vetturi li jibqgħu mhux miġbura u li għalihom ma jsir l-ebda hlas għal-liċenzji, kontravenzjonijiet, taxxa applikabbli u drittijiet oħra sat-Tlieta, 8 ta' April, 2025, se jiġu rkantati u, jekk mhux miġbura, se jiġu meqruda.

Notice to Owners of Vehicles Removed from the Road

In accordance with the Clamping and Removal of Motor Vehicles and Encumbering Objects Regulations SL.65.13, Transport Malta is hereby publishing a list of vehicles that were removed from the road for being in breach of the Motor Vehicles Registration and Licensing Act (Cap. 368) and the Registration and Licensing of Motor Vehicles Regulations S.L. 368.02 and which have not been retrieved by their lawful owners.

The list includes a description of the removed motor vehicle. The vehicles are currently being stored at Transport Malta's compound.

Respective owners are to retrieve their motor vehicle from Transport Malta upon submission of proof of ownership and upon payment of the applicable registration tax, licences, contraventions and other administration fees that may be due.

Vehicles which are not retrieved and for which any applicable registration tax, licences, contraventions and other fees are not paid by Tuesday, 8th April, 2025, will be auctioned and, if not sold, will be destroyed.
